When training is completed, fill out the form and submit to your Service Unit Manager for review and approval.

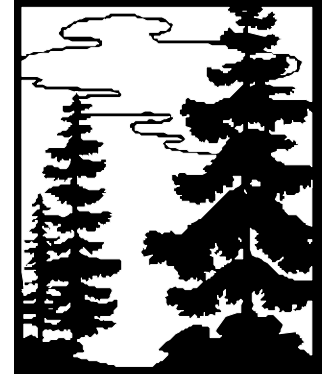
Upon approval, mail/fax the form to the council.

In October 2009 you will receive a confirmation e-mail from the council office informing you that your GSCNC Troop Camping Eligibility form has been processed and added to the system for the 2009-2010 camping season. It is important to note that if you are using an existing account, and you have changed your e-mail address since you created your account you must log into your account and update your information. All e-mail confirmations will be sent to the e-mail address that is currently listed on your account.

This form must be completed every year. If your troop already has a form on-file you may go on-line through September 30, 2009 to reserve a campsite. To use the on-line reservation system after September 30, 2009 you must submit a new form. Please keep a copy of the completed form for your records.
