GSCNC HONOR TROOP APPLICATION: September 1, - June 30,

At the beginning of the troop year, troop members decide if they want to work toward being recognized as an Honor Troop and integrate the requirements into their plans for the year. All requirements must be completed between September 1 and June 30. Troop qualification must be verified with signatures from troop leader, a girl troop member and the service unit manger. Completed form due to field director no later than August 15. Qualifying troops receive a patch and year bar for each girl in the troop.

HONOR TROOP REQUIREMENTS:

Membership

- The troop had a minimum of five girls and two registered adults.
- All girls in the troop were registered by October 31st.
- Troop invited non-Girl Scouts to participate in a troop or Bring-a-Friend activity to recruit new girls to Girl Scouting.
- All girls in the troop participating in the cookie sale were registered by December 15th.
- 50% of the girls in the troop participated in spring Early Bird registration and registrations were turned in by the deadline.

Adult Leadership

- Troop leaders/advisors have completed the volunteer application process, have current appointment letters and have completed basic leadership and appropriate level training.
- Troop was represented at all service unit meetings by leader/advisor or troop representative for entire meeting
- Troop leader/advisor is familiar with the council's inclusion and language outreach resources.

Program

- Girl Scout Leadership Experience - troop discovered, connected and took action for themselves, with each other and the community through girl-led, cooperative learning and learn by doing activities.
- Cookie Sale - 100% of the girls in the troop participated in the GSCNC cookie sale to meet an established troop goal.

Troop met at least three of the following requirements:

- Troop Camping Eligibility (Form B220) - troop completed and submitted form before October 1st.
- Service - troop planned and implemented at least one service project.
- Inclusion - troop supported the membership of girls with all abilities in the troop.
- Girl Scout Tradition - troop incorporated at least one Girl Scout "tradition" into their year (eg. ceremony, Scout's Own, sing-a-long, observation of Juliette Low's or the Girl Scout Birthday).
- Field Trips - troop planned and took at least one field trip.
- Out-of-doors - troop participated in a day or overnight event in the out-of-doors.
- Council resources - troop attended a council-sponsored program event, checked out a program kit or earned a council patch.
