A Super Service Unit is one that has provided quality program and support for both girls and adults, contributed to the retention and growth of membership, and helped the council achieve its goals. At the beginning of the Girl Scout year, the Service Unit Team, in consultation with the Field Director, decide if they want to work on being recognized as a Super Service Unit. All requirements must be completed between September 1 and June 30. This form must be submitted to GSCNC by July 15. Qualifying service units will receive a \$20 GSCNC Shop certificate OR a patch and year bar for each leader and SU team member.

**Supporting Troop Leaders/Advisors**

- Service Unit (SU) Team held a minimum of three SU Team meetings and a minimum of five SU meetings
- All new leaders/advisors participated in a welcoming conversation/orientation with a member of the SU team
- All volunteers were appointed by October 31 using GSCNC volunteer appointment form
- SU demonstrated appreciation for volunteer contributions at the SU and troop level

Service Unit met at least three of the following requirements:

- At least two "learning opportunities" for leaders/advisors were provided during SU meeting
- SU presented information to troop leader/advisor about the council's inclusion and language outreach resources -- web site, the lending and consultation with a specialist.
- SU provided opportunity for girls, parents and leaders/advisors to explore benefits of each level in the Girl Scout program to encourage progression (e.g. bridging, open house, mother daughter event).
- 50% of the troops in the SU earned Honor Troop
- SU supported at least one nomination packet for formal Adult Recognitions.

**Supporting the Council**

- The SU met or exceeded their on time goal
- SU met or exceeded their annual girl recruitment goal
- The SU met or exceeded their Early Bird goal.
- 80% of the troops in the SU had a minimum of five girls and two registered adult
- The SU invited non-Girl Scouts to participate in a SU or Bring-a-Friend activity to recruit new girl to Girl Scouting.
- At least 2 new troops were added to the SU after October 31st
- 100% of the troops participating in the cookie sale were registered by December 15th
- The SU sold more cookies during the cookie sale compared to the previous year
- All troops received SHARE materials and 100% troop participation
