- My child is registered as a Girl Scout for the 2026/2027 Girl Scout Program year.
- I accept financial responsibility, including prompt payment, for all product and money she receives and will also see that she has adult guidance at all times. I understand that unsold product may NOT be returned.
- I understand that no product or magazines will be sold before September 11, 2026, and that **money will be collected at the time orders are placed.**
- I accept responsibility for meeting all troop deadlines.
- All money collected will be turned in with my Girl Scout's orders. I understand that if money is not turned in with my Girl Scout's orders, I will not receive the product.
- I will ensure that all products ordered are delivered promptly to the customer.
- I understand that all proceeds are troop or Council funds and are NOT the property of my child as per GSUSA policy.
- I understand that personal checks over \$250.00 will not be accepted. For payment of more than \$250.00, **ONLY** accept cashier's checks or money orders. Each family is limited to checks totaling a maximum of \$250.00.
- Troops, youth members, or adults participating in the Fall Product Program may not have any outstanding debts with Girl Scouts Nation's Capital.

Fall Product Program Reward

Selling fall products is a wonderful service to the Council. Troops earn troop proceeds for activities, and the Council receives funds to provide programs, training, financial aid, and camp maintenance. Reward items are intended to motivate Girl Scouts in their selling efforts. **ONLY youth members earn rewards.** Girl Scouts who set a personal goal as well as a troop goal with the other members of their troop prove to be most successful.

Girl Scouts can earn rewards for selling products and magazines by taking orders. With Individual Reward items, each Girl Scout earns the rewards that coincide with the level of products and magazines sold. Individual Reward items are cumulative. As a troop, Girl Scouts can work towards Individual Reward items or they can opt to earn an additional 5% through Additional Proceeds. Each troop must decide, by majority vote, on their plan before the start of the Fall Product Program activities. To qualify, each Girl Scout and their parent/guardian must acknowledge acceptance of the Additional Proceeds option by signing below. Troops that choose Additional Proceeds will qualify for all patches available. (Juniors, Cadettes, Seniors, and Ambassadors can only opt-out)

WAIVER FOR ADDITIONAL PROCEEDS ACCEPTANCE:

- I am aware of the troop's decision to accept an additional 5% of troop proceeds in lieu of the Individual Rewards offered. I understand that I am also eligible to earn all of the available patches.
